#### PGA SECTION CHAMPIONS

The Champion from each of the 41 PGA Sections will earn an exemption into the Boys Junior PGA Championship. The Section Champion is identified based on the lowest gross score in the oldest age division.

#### CHAMPIONSHIP INFORMATION

- 144 Boys who are 18 and under through the final round of the Boys Junior PGA Championship on August 2, 2019.
- Players are not allowed to have caddies at any stage of the Championship, except in practice rounds.
- Application for entry is subject to acceptance by the PGA Section and the PGA of America, the administrator of the Championship.
- Applicant agrees that, in the event of acceptance, he may be rejected at any time and stage of the Championship.
- PGA reserves the right to limit entry, adjust dates, format and other details to fit conditions prevailing at the time of the event.
